

OBARO ONLINE'S PROMOTION TERMS AND CONDITIONS

1. The promoter is OBARO Online a Division of OBARO Retail (Pty) Ltd ("OBARO") with company registration number: 1998/001675/07 with registered address situated at c/o Graham and Silverlakes Road, Silverlakes, Pretoria, 0081
2. Participation in the promotion will be deemed acceptance of the rules, terms and conditions as stipulated herein.
3. The promotion is exclusive to South African residents who are 18 years or older, unless stated otherwise, and is closed to any person who are directors, members, partners, employees, agents or consultants of or any other person who directly or indirectly controls or is controlled by OBARO or marketing service providers, or spouses, life partners, business partners or immediate family members, or any person who is affiliated with OBARO. In addition, all OBARO employees are precluded from participation in the promotion.
